Please note: This email was sent to all the City Council and City Manager on Friday Sept9. Only responses from Jose Reynoso and Gene Goss. Very disappointed that the other Council Members could not take a couple minutes to acknowledge this issue!

During the Labor Day weekend, the Canyon Residents and others lost power 3 days in a row (9/2,9/3 & 9/4). These outages lasted up to 8 hours depending on the area. While we understand that all of California was under a flex alert and that saving energy was of utmost priority, we are unclear what happened to cause these outages and there was no notice given.

Most of us are conscientious environmentalists and do our part to conserve, many have solar panels and are adhering to the conservation needs of the community and the state. However, rolling blackouts were not mandated, and yet we still lost power.

We implore you as our City Council, our representatives with Southern California Edison (SCE) to find out what occurred, was this a planned repair? Could it have been avoided? If it was due to stress on the system, what can be done in the future to mitigate this so we are not dealing with extensive outages during the hottest part of the year. Enhancing the grid that serves the Canyon residents would be a priority!

These prolonged heatwaves are becoming more the norm, and with climate change upon us we need to prepare for the inevitable.

What can SCE do to repair, enhance or modify our transmission into the canyon to relieve this undue stress on the grid that serves our homes. Why was no notice given when it was clear repairs were being made for several days in a row?

We ask you to come back to us with answers to these questions and resolutions so that next summer we do not have to deal with these unexpected outages.

Item #: FIRST READING OF ORDINANCE NO. 1458 AMENDING CHAPTER 17.88 (TEMPORARY USE PERMITS OF TITLE 17 (ZONING) OF THE SIERRA MADRE MUNICIPAL CODE It is recommended that the City Council adopt Ordinance No. 1458 amending Chapter 17.88 (Temporary Use Permits) of Title 17 (Zoning) of the Sierra Madre Municipal Code.

My name is Leesa Puleo and I live across the street from the Alverno exit gate on West Highland Avenue. I have owned my home for 26 years. I believe the new ordinance No. 1458 is too easily revised for entities like Alverno who are overusing their facilities for event rentals and filming, which severely impacts neighbors. It is the main reason why several of us have come to the Council with the signature fraud situation several times. The new TUP code will make the process easier for the city but not our neighborhood. Particularly, Alverno has “traded” event rentals for an additional 15 days of filming; the hours of filming are also longer. This ONLY applies to Alverno and has no effect on other individuals in the community. We feel it UNFAIRLY impacts the neighbors surrounding Alverno. We feel we deserve the same right to a “Village Atmosphere” as everyone else!

Alverno has rarely, if ever, abided by the rules and regulations included in the TUP code and neighbors are fed up! In fact, just last Saturday, Alverno had an event that I measured at 95dB at 8:48 pm from my front yard. I called the police and the dispatcher asked ME what the noise ordinance is. He also indicated that there were others that made complaints (#220910-0020). I feel the police should know the codes contained in the TUP and have the ability to measure noise appropriately and ensure that Alverno follows these codes.

I would also like to add that I believe the City should include the final amended code(s), that are up for discussion during City Council meetings, in the meeting packet and available online, so that residents can be made aware of what is being discussed.

As a proud resident of Sierra Madre for 64 years, I would like to offer thoughts regarding the Mater Dolorosa property. Much like my own longstanding love of our town, the local Passionists have called this their cherished home for nearly 100 years. On older maps, you will find the area designated as Mt. Oliva Passionist Fathers Home. They have been good neighbors, and their peaceful presence here has been a blessing for generations of faithful who have experienced retreats, and for countless others attending programs benefiting the local community.

With this background in mind, I hope that some of our citizens will not make it their mission to draw battle lines with Mater Dolorosa. The large front portion of this private land has been vacant for so long that in many minds it is a public nature reserve that can never be touched. Now, reasonable and well-balanced proposals have been put forth for its eventual use.

Providing a peaceful environment for reflection has always been an integral part of the Passionist's retreat ministry, and will continue to be in the future. They have made efforts to craft a plan that minimizes impacts to the community. Gifting a sizable part of this land for protected open space and a park is a thoughtful act of goodwill by the Passionists, and the park provides public access that isn't currently available.

Consideration for their neighbors is evident, because the new park being offered has been placed in the southern portion, providing a green zone to separate the proposed development from existing neighbors. This is a very generous gesture, considering that if such an area had instead been placed to the north it could have provided more quiet isolation for the Retreat Center itself.

The development will help provide needed funding for Passionist ministries, and to care for aging priests and brothers who have dedicated their lives for the spiritual care of others. Some people who oppose the development plan might also bear in mind that this was once a larger tract of property, and portions of it that were sold years ago may have provided the land that their own homes now sit on.

We all realize that changing things we are used to can be painful and unwanted. In my years here in town I have certainly seen many changes, but the unique spirit of this community always remains. I sincerely support the Passionists and their plans for the Mater Dolorosa development project, and I know that in whatever way this finally gets accomplished, the spirit of Sierra Madre will continue to remain.

I have friends who are looking to move to Sierra Madre and cannot find a house to buy.

Last September, Governor Newsom signed The California Comeback Plan which invests an unprecedented \$22 billion in housing which will lead to the creation of over 84,000 new affordable homes for Californians, including over 44,000 new housing units. This Plan marks the most significant investment in housing in California's history with \$10.3 billion proposed for housing and over \$12 billion for the unhoused.

While there has been a great deal of opposition to this project, and to the question of increased housing, in general, I urge the City Board to consider of the advantages of this upscale housing for the benefit of the community as the whole.

As an attorney, author and longtime homeowner and resident of the western portion of Sierra Madre I'm writing to express my strong support for The Meadows at Bailey Canyon proposal. The Meadows is a detailed, well-considered plan that will substantially benefit the community and sustain the Passionists who own the property and operate Mater Dolorosa. The alternatives such as the high likelihood of protracted litigation, the potential for much more intense development such as a school, large skilled nursing facility, or high-intensity low income housing would have a negative effect on Sierra Madre. In contrast, the sustainability features of the project including groundwater recharge, all-electric homes, fire-resistant construction, a fully-funded city park, shifting the cost of the City's maintenance obligations for an adjoining portion of Bailey's Canyon Park and the net-zero water commitment will provide obvious benefits for our City. This is a responsible, sustainable, and collaborative project.

The Passionists Monastery has been model community members for the past 100 years. They have generously shared their lands and spaces with all Sierra Madre residents. During the pandemic they provided thousands of meals through their food ministry program. They have a growing need to monetize some of their property in order take care of their older members who have sacrificed so much over the years. As a litigator I believe the Passionists have exercised unusual forbearance and it is my hope that their patience bears fruit.

Some voices in our city in opposition to the project want no development at all, or to delay it indefinitely, which is simply not tenable under current law. Others hope to turn the property into a park or tree preserve. Those would be nice if there were some way to pay the Passionists, but that is not currently possible. The people who oppose the project justifiably question the impact of construction activity, but that is temporary, and steps can be taken to mitigate the negative aspects including noise, dust and construction vehicles. If this project turns out like other projects of this developer, the homes in the surrounding neighborhood will become significantly more valuable than they would be otherwise.

I am confident that the Councilmembers are carefully considering and analyzing the options available to the Passionists and will conclude that The Meadows proposal would best balance the rights and the interests of all Sierra Madre residents and stakeholders. We can welcome 42 new families and enhance the character of our community.

I respectfully request that the City Council approve The Meadows project and support sustainable development in Sierra Madre.

I write to express my support for the Meadows at Bailey Canyon.

The Meadows serves as a model for sustainable development and demonstrates a commitment to reducing the impacts of climate change through the inclusion of 100% electric homes.

Further, the project includes a wide variety of water saving features, including drought tolerant landscaping, high efficiency fixtures, and green stormwater infrastructure that recharges our local groundwater supply.

I believe the negative impacts of the residential development provides is very low. The traffic studies need to be explained to the common citizen in terms they can understand, i.e: "The traffic predictions would be similar to what other streets? Canon and Laurel at school drop off time or Laurel and Lima at anytime of day." The 700 trips sounds like a huge event. When the numbers may be true, let's explain them so others can understand what other intersections have similar traffic numbers to compare with.

I believe the zoning change to SFR is a better choice than the development of institutional use. Sierra Madre can have another neighborhood similar in density to many other blocks in town. I appreciate the diverse architectural styles proposed. The construction schedule though intense for a few years, will be done and over with. The developer building many at one time, can hopefully achieve the discounts of bulk ordering to extend the price discounts to the sale price. The residential development allows for the retreat center to be a compatible historic neighbor and use their partial land sale as an asset to continue their mission of service.

I understand from talking with Marc Blain, a Senior Wildlife Biologist with PSOMAS environmental group, the property designated for development as SFR would create substantially more wildlife habitat than if preserved as is.

I support adding a Labyrinth to the proposed Meadows public park as a gesture to a spiritual path the Father's walk and a recognition of their generosity and service. I believe it will be well suited for this type of quieter park versus a sport type of park. Even more so if it could be built with low maintenance for wide pathways for accessibility to those in a chair, walker or needing to have assistance. I personally have training in the construction of labyrinths as such public benefits and would be happy to share my knowledge.

Development is the property owner's right. I appreciate their sensitivity to the residents to consider what is best a win-win solution. I support sustainable projects like the Meadows and hope you will represent the voice of the community membership along with your knowledge of the the visions of a Sierra Madre Community Development for future generations to continue being proud to live and be from Sierra Madre.

Dear Mayor Goss, Mayor Pro Tem Garcia, and City Council Members,

My name is Jessica Shore Sarber and I am writing on behalf of my mother, Queenie Shore, and our family property at [REDACTED] located at the southeastern border of the proposed Meadows at Bailey Canyon development which is a critical area in the development design. My family is neither for or against the Mater Dolorosa development of their property.

I am requesting an immediate stay of all consideration for approval of the Meadows at Bailey Canyon project due to what my sisters and I consider negligence in the design proposal. We have reached out numerous times to the Developer, as recommended by the Planning Commission and the City Attorney. Within the last month, the Developer has responded in writing, however there are still two very serious details which show negligence in the EIR and Specific Plan.

There has not been a structural engineering study nor a geotechnical study of the retaining walls and soils at the southern border. It is unknown whether the existing walls can withstand the proposed infrastructure and proposed park design and amenities. We find the absence of a structural engineering assessment of the retaining is seriously negligent, especially since this is a critical point where incoming and outgoing utilities and water drainage systems are planned.

An assessment by an independent licensed structural engineer must be completed to protect the existing homes, properties, and residents along the southern boundary from unintended consequences during and after construction. Currently, the Specific Plan, the EIR, the Dudek reports and reviews, and NUWI have omitted or neglected to review whether the existing structures will bear the increased load from heavy construction equipment, utility placement, and increased water flows redirected to this lower elevation.

It is critical to all parties and the development design that the integrity of the wall and all southern bordering walls be a known factor before any infrastructure or park design is presented or approved. Recently, NUWI has confirmed directly to my family that a structural engineering study will be completed, however not until the start of construction. This timing minimizes due diligence and the concern over any possible findings which might require redesign, delays and higher costs not only to the contractor but also to the City and the Mater Dolorosa. In my multiple requests to Mr. Frankel since February 2022 that the structural integrity of the retaining walls be reviewed and assessed, I have clarified that I am not an engineer and I stated that I am unaware of the condition or strength of these walls. Mr. Frankel has unfortunately misunderstood this to mean that I do not believe there is a concern. This is not true as shown in multiple appeals to the Developer and the Planning Commission over the last seven months. To add to the concerns of the design, which places most of the underground utilities near and against the wall at my family's property, NUWI seems to be unaware of whether the retaining walls are continuous across the southern boarder or whether there are gaps at any point in the wall. It is also a known fact that homes with in-the-ground pools a few feet from their retaining walls may experience cracks and damage in their pools due to shifting ground pressure, an issue that no one has addressed to date. Certainty of the structural integrity of the retaining walls, especially at our property, will benefit the development and will eliminate revisions and delays, unless it is the developer's intention to cause delays or even worse, push possible long-term damage due to negligence in this area to the City of Sierra Madre.

This is particularly troubling given the foreseeable hazards raised in a July 30, 2020, letter from the Los Angeles County Flood Control District available in the EIR documents. If unaddressed, these risks include mudslides and debris flows from rains following wildfires, regardless of whether flooding rises to a 500-year level. This threatens all residents along the southern border and could also put neighboring residents and homes in harm's way. This particular situation may be exacerbated by the Developer's intended use of impermeable paving and surfaces throughout the development, which is a known contributing factor in forcing water run off to the lowest elevation, instead of permeable and porous surfaces. The Developer has represented that impermeable surfaces were chosen to prevent the underlying infrastructure from shifting. This explanation raises concerns that the ground may not be stable enough or at risk of erosion should the site be developed. We request that the use of permeable surfaces be addressed by a third-party expert and presented to the City Council for review before any consideration of furthering the project.

Finally, it must be noted that elderly and children live at the properties aligning the retaining walls, and their well-being and safety are being ignored by the lack of due diligence. The walls are within twelve to twenty feet of the home structures, so the likelihood of standing or being active at or near the retaining walls is high.

We remain extremely concerned about the serious impacts of a design that has not taken into consideration the integrity and soils at the southern border retaining walls. We are particularly concerned that the failures cited above will be wrongly baked in as tacitly approved by the City if they are not resolved prior to formal action.

I'd like to bring to the attention of the public that the mayor and city council members wrote and signed off on an argument against Measure HR for the voter pamphlet which contained FALSE information that would be used by voters to determine their vote on measure HR, and that they lost in court. This FALSE voter information was provided to the city council by City Attorney Giragosian; his firm represented the City Council in the lawsuit. Rather than blaming the citizens for the cost to the city, which councilwoman Arizmendi did in a recent op ed in the Mountain View News, the cost should be borne by Mr. Giragosian's law firm, Colantuono, Highsmith, and Whatley PC, both for what they charged the city and for Protect Sierra Madre's attorney's fees.

In the judge's decision, he stated: "The statement is not just imprecise, it is false. No matter whether a commercial entity or an individual, no single person could develop the Property's 35 acres into 68 units. Neither SB 9 nor the City's SB 9 Ordinance would permit it. Yet, the statement's plain meaning is that a single developer could build up to 68 units on the Property."

In a previous city council meeting, Mayor Goss made the statement that supporters of Measure HR were uninformed. It seems that it is the Mayor and the City Council who are uninformed and putting out false information even though several months before, they had been presented correct information by Mr. Giragosian. All of them seemed to have no recollection and they also did not bother to check that what they write and say is TRUE. This also points out that the City Council needs to do their own due diligence and not rely on the city attorney and city staff.

You, the City Council, have shown your bias for New Urban West's proposal to build 42 large houses stacked together on tiny lots in a severe-high-fire area where they clearly don't belong against the best interests of the citizens of Sierra Madre. Just like Measure V, which was to preserve the character of downtown Sierra Madre, where the citizens of Sierra Madre did not believe that the city council was acting in their best interests, we have done what we had to do by putting the issue on the ballot. All we ask is that you let the citizens of Sierra Madre vote on Measure HR based on ACCURATE and realistic information and that you defer decision on the Meadows Project until after that vote so that the wishes of the citizens can be heard.

Comments on the Temporary Use Permit Ordinance Amendments
Alverno Heights Academy
Statement by Ken Farfsing, President, Board of Trustees
September 13, 2022

Honorable Mayor Goss and city council members, I am Ken Farfsing, president of the Alverno Heights Academy Board of Trustees. Alverno's application for the adaptive reuse of the historic Villa Del Sol d'Oro is currently before the Planning Commission. The draft conditions closely mirror the proposed city-wide temporary use permit ordinance.

The Commission has held two public hearings on the Villa's adaptive reuse permit and the hearing was continued to October 6th. Substantial progress has been made. The school has worked with the Commission and staff to limit the number of Friday and Saturday events in the Villa. No rental events will be held on Sundays. The school has agreed to fund an independent event monitor subject to approval by the city. Staff and Alverno are finalizing a standardized checklist to be used by the event monitor.

Among dozens of conditions, the Commission established noise limits and reviewed the traffic and parking management plan. In order to further mitigate noise impacts, the school purchased four portable air conditioners for the Villa's downstairs event area, as we work with staff on permanent solutions. Alverno appreciates that all of these efforts have not gone unnoticed by the City.


We have one issue where Council direction is requested. The current draft of the conditions have all music and bar service ending at 9:30 p.m. All events are to end at 10:00 p.m. and the parking lot lights are to be turned off at 10:15 p.m. These are reasonable and the school has begun working with our vendors and parties to adapt to these standards

Our major issue remains the restrictions on the event clean-up inside the Villa. We are requesting that the interior clean-up of the Villa be allowed to proceed until 10:30 p.m. This is a health and safety issue for vector and insect control. The Council discussed our request at your June meeting and there was a tie vote. Two members supported the 10:30 p.m. clean-up time, while two members did not. Council Member Kreibs was not present, so there was no final direction to the Commission.

The Commission's main focus has been on making sure all events follow the same standards. However, the Council has created an exemption for adaptive reuse of historic structures and for Institutional uses under a conditional use permit and master plan. There are facts that mitigate Alverno's request, including the large size of the campus and the internal location of the vendor parking area. We have prepared a site map illustrating that the vendor area is located approximately 240 feet from homes on Wilson Avenue and 310 feet from homes on Michillinda Avenue.

Our 10:30 p.m. request can either be handled in the Villa's permit or you can address this issue in tonight's ordinance, by allowing event clean-up to continue until 10:30 p.m. Either way, your direction is requested. There are a number of events in Sierra Madre which could benefit from allowing the clean-up inside buildings until 10:30 p.m., including the Harvest Festival.

We appreciate your consideration of our request.

Dear Mayor Goss, Mayor Pro-Tem Garcia, and Council Members,

I am extremely disappointed to see the city remove the bike lane on Sierra Madre Blvd in front of the Library. The loss of the bike lane, along with the angled parking that was installed, creates a hazardous condition for drivers and especially for people on bikes. For a person traveling eastbound on Sierra Madre blvd, the bike lane abruptly ends at Park, forcing a person on a bike to merge into the travel lane with cars going as fast as 35mph. While doing this, the person biking must look over their left shoulder to make sure the merge is safe while simultaneously being prepared for the possibility that a driver might back out of one of the new diagonal parking spaces on the right. This maneuver is challenging to even the most experienced cyclists, not to mention a less experienced rider, a child, or an older adult. Frankly, this creates a danger zone that will intimidate all but the most confident riders, and limits the number of residents willing to bike to the library, the park, or other restaurants and shops on Sierra Madre Blvd.

The design also creates a hazard for drivers. The person backing out of the diagonal parking may not see oncoming traffic, because the view may be obstructed by another diagonally parked car. Further, for anyone exiting the library driveway on Sierra Madre Blvd, the diagonally parked cars also block the view of oncoming traffic. In short, the redesign of this stretch of Sierra Madre Blvd has created a road hazard and the question is not if, but when, a collision occurs.

The bike lanes on Sierra Madre Blvd were already in disrepair and I had hoped the road construction project would have been for the purpose of improving them so that the city could enable more residents to feel safe enough to bike for some of their local trips. Imagine my dismay when the city not only did not repair the bike lane, but removed it.

It is essential, not optional, that Sierra Madreans of all ages and abilities have safe streets for walking and biking. It is good to see our city embrace wellness, but our streets don't embrace wellness. It is good to see our city embrace sustainability, but our streets don't embrace sustainability. Whether our goal is safety for everyone, community health and wellness, equitable access to our downtown, traffic reduction, or reducing GHG emissions and air pollution, having streets that enable more residents to have active mobility choices is of critical importance. You do this by improving the bike lane, not removing it. Otherwise none of these goals will be reached.

In the short term, I am requesting that the city restore the library bike lane. We must create an active mobility plan for the town and have an action plan to follow through on it. We need safe streets for all Sierra Madreans. The city should improve the bike lanes, not remove them.

Dear Sierra Madre Councilmembers:

I am writing to protest the erasure of a section of the bike lane on Sierra Madre Blvd. in front of the public library. The area in front of the library has been converted from curb parking and the bike lane into angled car parking spaces and a large gap in the bike lane.

So now as I am riding, I am abruptly forced into the traffic lane in front of vehicles for several yards as I pass the library, and then back to the bike lane, and then am forced back into traffic where the bike lane abruptly ends. The new paving has been painted with "sharrows," which numerous studies have proven to be 100% useless as a safety measure for riders and drivers. Most people on the street don't even know what they are, much less how they're supposed to interpret them!

I am both a bike rider and a car driver. This forced cutting in and out is dangerous-to everybody. It should be obvious how it creates stress for a bike rider whose slim lane disappears and reappears and disappears, but it also creates stress for the driver who is on Sierra Madre and also the driver backing out of a space and into the street. Except that on a bike, you feel a lot more vulnerable to cars and drivers.

One of the core principles of safe driving and riding is predictability. Anyone who has experienced a driver, bike rider, skateboarder, or even pedestrian swerving in and out of traffic, whatever type of traffic is, has felt the stress that this creates, and it often causes us to react instinctively, causing ourselves to swerve out of the way. And it makes us scared, which makes us mad. It's a really effective way to piss off the people around you. Drivers don't pay attention to bike lanes; their experience will be that I'm *getting in and out of their way*.

I know that many people in this town think of bike riders only in connection with packs of Spandex recreational weekend riders, but we need to start thinking of biking as a mode of local transportation. With e-bikes now in the mainstream, and incentives coming online, many people are seriously interested in hopping on a bike for their local transportation. Every time I'm out on my e-bike, I get comments and interest from people who are thinking about one for their transportation.

Growing numbers of us are tired of paying for gas and insurance, and sitting in traffic and jockeying for parking. We're tired of polluting the air and seeing the results in frequent

extreme heat and wildfires. We're tired of burning fossil fuels. We're tired of driving simply for lack of better options to get around.

Biking is a perfect alternative to driving, especially in our town. Sierra Madre is small and compact, with so many pretty streets to enjoy by bike, as many of us do on foot. It's time-efficient: faster than walking, not much slower than driving. On my bike, I get fresh air, some exercise to get my blood moving, I say hello to neighbors, I feel happier, and I get to the pool or Taylor's or the post office or Lucky Baldwin's. My daily errands are fun now instead of a gas-eating drag.

I'm not a sporty type, nor am I anti-car. In fact, I have a car I adore (as do my neighbors), I've been a professional driver for an arts organization, and I love to drive—when I don't *have* to.

Riding a bike and wanting streets that we all can safely share is not an either/or against cars.

While my comment is triggered by the terrible bike lane / parking decision in front of the library, it points to a larger proposition for Sierra Madre.

I think we need to do a broad re-visioning of how we use our public space in the business heart of town. Right now, it's a piecemeal mix of really wonderful assets, like the public seating in our town "triangle-square" at Kersting Court and the beloved local businesses we enjoy there, with bad elements like the intersection of Sierra Madre Blvd. and Baldwin, which is dangerous and regressively designed.

Yes, designed: streets are designed, with priorities, and can be re-designed, with a large toolkit at our disposal to make streets safe, calm, easy to navigate, and beautiful. Or not.

We need to look at what our values are, and how to look at our public space – our streets, sidewalks, and triangle-square – as amenities we all should be able to enjoy safely.

Can we envision a town center that supports the things we love about this town: slowing down, neighborliness, locally owned businesses, trees and greenery, and palpable connections with the bright points of our history? Can we envision how we can integrate access for everyone instead of carving away space from one group or another?

Can we look beyond what we've accustomed to, gain inspiration from what other towns have achieved, and adopt those techniques or features into our own local vision? And can we plan for a physically and socially sustainable future – a Sierra Madre that our kids will want to raise their kids in?

I think we can. It takes leadership and vision. I call on City Councilmembers to find this

leadership and vision.

It may start with a bike lane and a few parking spaces in front of the library – and that situation should be remedied right away, for our safety – but please make it lead to a more considered, holistic plan for our public space in the heart of Sierra Madre.
